The purchase price is for the dog alone and any other expenses will be paid by the purchaser, such as transportation, crate, club membership, etc.

TERMS OF SALE:

1. A 4 generation pedigree will be provided at the time of purchase along with any and all papers needed for proper registration. The dog must be registered with the Premier Kennel name preceding his/her given name, i.e. Premier's Rising Star. The kennel name must remain a permanent part of the dog's official name and must be used should the dog be shown or bred.
2. It is understood at the time of sale that this dog is representative of the Polish Owczarek Nizinny/Polish Lowland Sheepdog and is structurally and temperamentally sound. There is no guarantee of the adult quality as to show or breeding quality, color or coat.
3. This puppy is guaranteed for 72 hours against any health irregularities. This guarantee is only valid if the puppy is examined by a licensed veterinarian during this time.
4. The puppy may, for any reason, be returned to the Seller/Breeder within 6 months and the Seller/Breeder will refund to the Purchaser the full amount of the purchase price. The Purchaser is responsible for any and all transportation expenses and warrants the health, appearance and temperament of the above described puppy.
5. Should the Purchaser ever wish to sell or dispose of the above named dog, the Seller/Breeder must be contacted first and has the right of first refusal. The Seller/Breeder will either purchase the dog at a fair and reasonable market price or will assist in placing the dog in a new home. Should the dog be found to

have a physical defect (prior to 25 months of age) that affects the reason for purchase then the Seller/Breeder will take the dog back and return an agreed upon amount up to the full purchase price.

6. The Purchaser agrees not to use this dog for breeding unless upon maturity (24 months) the Seller/Breeder agrees the dog is a good representation of the breed and has obtained the title of AKC Champion. At that time, the Seller/Breeder will assist if requested in the location of a proper stud/bitch. Prior to consideration of breeding, the dog must have radiographs performed on or after 24 months of age for OFA Certification and must be certified excellent, good or fair or receive a PennHip Evaluation with a rating which meets or exceeds the established Distraction Index. The eyes must be tested and Certified clear of hereditary eye defects. Copies of the results must be provided to the Seller/Breeder.

7. If the puppy is sold as a pet quality only and will not be shown in Conformation at any time, the Purchaser agrees to have the puppy spayed or neutered if required by the Seller/Breeder and the Seller/Breeder is to receive a copy of the spay/neuter certificate. No action on this procedure can be taken without first consulting the Seller/ Breeder.

8. Under no circumstances will this dog or its offspring be sold to a pet store or anyone else interested in raising the breed for any purpose other than promoting the best interest of the breed.

9. The Seller/Breeder has brought this dog into the world fully realizing the magnitude of the responsibility to the breed. The Seller/Breeder has made every effort to find the perfect home for this puppy and to educate the Purchaser to the breed. The Seller/Breeder encourages open communication and wishes to be kept informed of the puppy's activities, including pictures, letters and phone calls.

The above mutual agreement is made for the protection of the puppy, the Purchaser and the Seller/Breeder. It is, therefore, understood and agreed to by both the Purchaser(s) and the Seller/Breeder and that the Laws of the State of Florida apply to this contract.
